

VAULT REWARDS HONEYMOON INSTANT WIN GAME AND SWEEPSTAKES 2023
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING. - 1. PROMOTION PERIOD:** The Promotion begins on October 2, 2023 at 12:00 PM Eastern Time ("ET") and ends on November 30, 2023 at 11:59:59 PM ET ("Promotion Period"). The Promotion consists of an "Instant Win Game" and a "Sweepstakes." The Administrator's computer is the Promotion's official clock.

- 2. ELIGIBILITY:** This Promotion is open only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Must be a member of the Vault Rewards program and have either a Jared account, a Kay account, a Kay Outlet account, a Zales account, or a Zales Outlet account to participate in this Promotion. Membership in the Vault Rewards program is free. If you are not a member of the Vault Rewards program, you can sign up by visiting either www.jared.com/vault-rewards, www.kay.com/vault-rewards, www.kayoutlet.com/vault-rewards, www.zales.com/vault-rewards, or www.zalesoutlet.com/vault-rewards and creating an account. Jared, Kay, Kay Outlet, Zales and Zales Outlet accounts are also free. If you do not have a Jared account, you can sign up by visiting www.jared.com, if you do not have a Kay account, you can sign up by visiting www.kay.com, if you do not have a Kay Outlet account, you can sign up by visiting www.kayoutlet.com, if you do not have a Zales account you can sign up by visiting www.zales.com and if you do not have a Zales Outlet account you can sign up by visiting www.zalesoutlet.com. Employees of Sponsor, Administrator, and Jared the Galleria of Jewelry® retail stores, Kay Jewelers® retail stores, Kay® Outlet retail stores, Zales® retail stores, Zales Outlet® retail stores, Epsilon, and each of their respective owners, parent companies, affiliates, directors, subsidiaries, franchisees, representatives, advertising, promotion and production agencies, agents (collectively, the "Promotion Entities") and each of their immediate family members (*i.e.*, spouse, parent, stepparent, child, stepchild, sibling, stepsibling, and their respective spouses, regardless of where they reside) and persons living in the same household of each are not eligible to enter or win the Instant Win Game or Sweepstakes. Void in Puerto Rico, all U.S. territories and possessions, and where prohibited or restricted by law. All federal, state and local laws apply.

Participation in this Promotion constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor and Administrator's decisions and interpretations, which are final and binding in all matters related to the Promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein. Entrants and/or potential winners may be required to provide proof of identification and eligibility as required by Sponsor or Administrator. For purposes of the Promotion, an entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to

change their physical address or e-mail address. If it is discovered or suspected that an entrant has registered or attempted to register for the Promotion using multiple e-mail addresses or multiple identities, that entrant's entries will be declared null and void and any prize an entrant might have been entitled to win will not be awarded and may be revoked.

3. HOW TO PARTICIPATE: During the Promotion Period, eligible entrants must visit <https://vaultrewardssweepstakes.com> ("Website") and complete and submit the registration form including, but not limited to, his/her first and complete last name (no initials), valid e-mail address, phone number, street address (no P.O. Boxes will be allowed), city, state, and zip code and answer the required questions. After submitting a registration form, the entrant may enter the Promotion as follows:

A. Instant Win Game Play: Upon submitting his/her registration form, the entrant must then follow the on-screen instructions to play the Instant Win Game by selecting a gift card prize category ("Instant Win Game Play"). There are four (4) Instant Win gift card prize categories an entrant may pick: (i) flowers; (ii) golf; (iii) home improvement; or (iv) Jared, Kay or Zales. Once a gift card prize category is selected, it may not be changed, and the entrant will have a chance to win a gift card associated with that category. After the Instant Win Game Play, the entrant will automatically receive notification on the Website screen as to whether he/she is a potential "Instant Winner" ("Notification"). Each entrant that receives a winning Notification will be deemed a potential Instant Winner of the gift card in the prize category he/she selected, subject to verification of the entrant's eligibility and compliance with these Official Rules, as determined by Sponsor and/or Administrator in its sole discretion.

B. Sweepstakes: Each entrant that participates in the Instant Win Game Play will automatically receive one (1) entry into the Sweepstakes.

C. Share with Friends: After following the instructions on the Website to register and participate in the Instant Win Game Play, an entrant may obtain additional Sweepstakes entries during the Promotion Period by sharing the Promotion as follows:

i. Upon completing the Instant Win Game Play, entrant will be presented with options to share the Promotion by clicking the buttons to share the Promotion via Facebook®, Twitter®, or via a personalized URL. Once entrant selects a share option by clicking the related button, either: (1) a message with a unique personalized URL will be posted to the entrant's choice of his/her Facebook Wall, Twitter Feed, or (2) a message with a unique link will be created which eligible entrants may share with friends ("Invitation Post").

ii. To obtain bonus Sweepstakes entries, an entrant's friend/follower must click on the unique link in the Invitation Post and complete and submit the registration information requested and enter the Promotion. Upon the friend's/follower's successful entry into the Promotion, the original entrant will receive one (1) bonus Sweepstakes entry. There is a limit of five (5) bonus Sweepstakes entries per available method (5 via Facebook Share, 5 via Twitter Share, and 5 via Personalized URL), for a total of fifteen (15) bonus entries per person during the Promotion Period.

An entrant is not a winner of any prize, even if the Notification should so indicate, unless and until entrant's eligibility and the potential winning Instant Win Game Play have been verified and entrant has been notified that verification is complete. Sponsor will not accept screen shots or other evidence of winning in lieu of its validation process. Any Instant Win Game Play that occurs after the system has failed for any reason is deemed a defective play, is void, and will not be honored.

4. **RANDOM DRAWING:** On or around December 1, 2023, Administrator will randomly select one (1) potential Sweepstakes prize winner from among all eligible entries received during the Promotion Period. The winner shall be considered a potential winner, pending verification of his/her eligibility and compliance with these Official Rules, as determined by Sponsor and Administrator, in their sole and absolute discretion.

5. **PRIZES, ODDS OF WINNING, AND APPROXIMATE RETAIL VALUE ("ARV"):**

A. **Instant Win Game Prizes (108):** There will be one hundred eight (108) Instant Win Game prizes available ("Instant Win Game Prizes"). Each Instant Win Game Prize is one (1), one hundred dollar (\$100) electronic retailer gift card associated with the prize category the potential winner selected during registration, as follows: (i) flowers is associated with a flower retailer gift card (twenty-four [24] Instant Win Game Prizes available in this category); (ii) golf is associated with a golf-related card (twenty-four [24] Instant Win Game Prizes available in this category); (iii) home improvement is associated with a home improvement store gift card (twenty-four [24] Instant Win Game Prizes available in this category); or (iv) Jared (awarded as a Jared gift card), Kay (awarded as a Kay gift card), or Zales (awarded as a Zales gift card); there are twelve [12] Instant Win Game Prizes from each brand). Home décor, beauty, and restaurant gift cards are determined by Sponsor in its sole discretion. The ARV of each Instant Win Game Prize is \$100 USD.

B. **Sweepstakes Prize (1):** There will be one (1) Sweepstakes prize available, which is ten thousand dollars (\$10,000) awarded in cash via electronic transfer ("Sweepstakes Prize"). No more than one (1) Sweepstakes Prize will be awarded. To account for certain taxable amounts on the Sweepstakes Prize, Sponsor will increase the Sweepstakes Prize by \$6,000. However, the Sweepstakes Prize winner is responsible for payment of all taxes on all monies received. The ARV of the Sweepstakes Prize is \$16,000 USD.

C. Total ARV: The total ARV of all available prizes in the Promotion is \$26,800 USD.

D. Odds of Winning/Limit: The odds of winning a Sweepstakes Prize depend on the total number of eligible Sweepstakes entries received during the Promotion Period. The odds of winning an Instant Win Game Prize depend on when the entrant completes an Instant Win Game Play. Instant Win Game Prizes will be made available at random times throughout the Promotion Period. To be a potential winner of an Instant Win Game Prize, an entrant's Instant Win Game Play must have occurred at the exact randomly predetermined winning time as determined by Sponsor and/or Administrator. If an entrant's Instant Win Game Play does not occur at the exact randomly predetermined winning time, then the next entrant's Instant Win Game Play to occur after that first entrant's Instant Win Game Play will be deemed a potential Instant Winner. The number of Instant Win Game Prizes available to be won will decrease during the Promotion Period as prizes are awarded and claimed. There is a limit of one (1) Sweepstakes Prize and one (1) Instant Win Game Prize per person during the Promotion Period.

E. General Prize Restrictions: The use of a gift card is subject to the terms and conditions set forth thereon which shall govern the use of the gift card. Use of a gift card constitutes the user's acceptance of the terms and conditions, so the winners should read the terms and conditions on the gift card carefully. Winners must protect the gift card and treat the gift card as he/she would any other valuable document. The gift cards will not be redeemed or exchanged for cash, except where required by law. The gift cards are awarded on an "as is" basis, will not be replaced or replenished if it lost, stolen, damaged, destroyed or used without the winner's permission and will be voided if altered or defaced. Specifically, as it relates to the Jared, Kay, and Zales Instant Win Game Prizes, and without limitation of the foregoing, the Jared, Kay, and Zales gift cards cannot be transferred, used as payment for exchanges, purchases of additional gift cards, or as an adjustment to prior purchase(s) or applied as payment on any account. In no event will more than the stated number of prizes, be awarded. If, for any reason, more prize notifications are sent (or more claims are received) than the number of prizes offered, as set forth in these Official Rules, Sponsor reserves the right to award the intended number of prizes through a random drawing from among all valid and eligible prize claims received.

6. HOW TO CLAIM A PRIZE: After the random drawing, Administrator will notify the potential Sweepstakes Prize winner via e-mail at the e-mail address provided at the time of registration. Before being declared the official winner of the Sweepstakes Prize, the potential Sweepstakes Prize winner will be required to execute and return an Affidavit of Eligibility/Liability & Publicity Release (except where prohibited) and tax acknowledgment ("Affidavit") and any other requested documents. The potential Sweepstakes Prize winner must return a fully executed and notarized Affidavit to the Sponsor or its authorized designee within ten (10) calendar days from the date such Affidavit it is postmarked as being sent to the potential winner or the prize may (in Sponsor's sole discretion) be forfeited. All potential prize winners may be requested to provide additional documentation for verification purposes. Sponsor reserves the right to conduct a background check on any potential winner and reserves the right in its sole discretion to disqualify any person based on such background check if Sponsor determines in its sole discretion that awarding the prize to such potential winner might reflect negatively on Sponsor or Administrator. Failure by potential prize winners to agree to a background check may also result in disqualification. Failure to provide all required information and a signature on the documents within the stated time period, or where the prospective prize winner does not pass Sponsor's background check (in its sole discretion), may result in forfeiture of a potential winner's right to claim his/her prize, and may result in the prize being

awarded to an alternate potential winner. If a potential winner is disqualified, found to be ineligible or not in compliance with these Official Rules, or declines to accept a prize, the respective prize may be forfeited. If a prize is forfeited, the prize may be awarded to an alternate potential winner, selected in a random drawing from among all remaining eligible entries (or non-winning Instant Win Game Plays), as determined by Sponsor in its sole discretion. Sponsor or Administrator will attempt to notify each potential winner as set forth above, but Sponsor and Administrator are not responsible for any undelivered e-mails, including without limitation e-mails that are not received because of a potential winner's privacy or spam filter settings which may divert any Promotion e-mail, including any potential winner notification e-mail, to a spam or junk folder. The right to receive a prize is non-assignable, non-transferable and no prize substitution, exchange or cash equivalent will be allowed, except by Sponsor, who reserves the right to substitute a prize of equal or greater value in case of unavailability of a prize or force majeure, at Sponsor's sole and absolute discretion. Promotion Entities shall not be held responsible for any delays in awarding the prize for any reason.

LIMITATION OF LIABILITY:** By participating in this Promotion entrants agree that the Promotion Entities and each of their respective affiliates, subsidiaries, parent, advertising and promotion agencies, representatives, consultants, contractors, legal counsel, advertising, public relations, promotional, fulfillment and marketing agencies, website providers, Web masters and their respective officers, directors, stockholders, employees, representatives, designees and agents (collectively, "Released Parties") are not responsible for: (i) mutilated, illegible, stolen, postage due, or undeliverable e-mail/text notifications or postal mail, or any combination thereof; (ii) any computer, telephone, satellite, cable, network, electronic or Internet hardware or software malfunctions, failures, connections or availability, or inability to access the Website; (iii) corrupt or jumbled transmissions, service provider/network/Internet/Website/use net accessibility, availability or traffic congestion; (iv) any technical, mechanical, printing, or typographical or other error; (v) unauthorized human intervention, or the incorrect or inaccurate capture of information (including registration information), or the failure to capture, or loss of, any such information, whether caused by any Website users, tampering, hacking or by any of the equipment or programming associated with or utilized in the Promotion; (vi) any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Website or any Promotion-related website(s); (vii) any injury or damage, whether personal or property, to participants' or to any person's computer related to or resulting from participating in the Promotion and/or accepting or using a prize; and (viii) the Released Parties shall not be responsible or liable for entries that are entered by any automated computer, program, mechanism or device, for any entries in excess of the stated limit or for entries that are late, forged, lost, misplaced, misdirected, tampered with, incomplete, deleted, damaged, garbled or otherwise not in compliance with the Official Rules. right, in its sole discretion, to cancel, terminate, modify or suspend the Promotion and/or proceed with the Promotion, including the selection of winners in a manner it deems fair and reasonable including the selection of the winners from among eligible Instant Win Game Plays/Sweepstakes entries and bonus Sweepstakes entries received prior to such cancellation, termination, modification or suspension. In no event will more prizes be awarded than are stated in these Official Rules. In the event that, due to technical, typographical, mechanical or other errors, there are more winners than are stated in these Official Rules, a random drawing among the claimants will be held to determine the winners. Consenting to receive such emails is optional and does not have to be agreed to in order to be eligible to enter the Promotion and does not improve your chances of winning.
