- 1. PROMOTION PERIOD:** The Promotion begins on February 5, 2024 at 1:00 PM Eastern Time ("ET") and ends on February 29, 2024 at 11:59:59 PM ET ("Promotion Period"). The Administrator's computer is the Promotion's official clock.

- 2. ELIGIBILITY:** This Promotion is open only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Must be a member of the Vault Rewards program and have a Jared, Kay, Kay Outlet, Zales, or Zales Outlet account (each individually a "Banner Account" and collectively the "Banner Accounts") to participate in this Promotion. Membership in the Vault Rewards program is free. If you are not a member of the Vault Rewards program, you can sign up by visiting either www.jared.com/vault-rewards, www.kay.com/vault-rewards, www.kayoutlet.com/vault-rewards, www.zales.com/vault-rewards, or www.zalesoutlet.com/vault-rewards and signing up for the Vault Rewards program. Banner Accounts are also free. If you do not have a Banner Account, you can sign up by visiting www.jared.com, www.kay.com, www.kayoutlet.com, www.zales.com, or www.zalesoutlet.com. Employees of Sponsor, Administrator, and Jared the Galleria of Jewelry® retail stores, Kay Jewelers® retail stores, Kay® Outlet retail stores, Zales® retail stores, Zales Outlet® retail stores, Epsilon, or any other entities engaged in the development, distribution, implementation or administration of the Promotion, including third party fulfillment agencies and all local sponsors, and each of their respective owners, parent companies, directors, subsidiaries, representatives, affiliates, agents, and advertising and promotion or production agencies (collectively, "Promotion Entities") and each of their immediate family members (e.g., spouse, parent, stepparent, child, stepchild, sibling, stepsibling, and their respective spouses, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win the Promotion. All federal, state, and local laws apply. Void in Puerto Rico, all U.S. territories and possessions, and where prohibited or restricted by law.

Participation in this Promotion constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's and Administrator's decisions and interpretations, which are final and binding in all matters related to the Promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein. Entrants and/or potential winners may be required to provide proof of identification and eligibility as required by Sponsor or Administrator. For purposes of the Promotion, an entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical address or e-mail address. If it is discovered or suspected that an entrant has registered or attempted to register for the Promotion using multiple e-mail addresses or multiple identities, that entrant's entries will be declared null and void and any prize an entrant might have been entitled to win will not be awarded and may be revoked. - 3. HOW TO ENTER THE PROMOTION:** During the Promotion Period, an eligible entrant must log into his/her Banner Account. Entrant must then click on the link to this Promotion or may visit VaultRewardsSweepstakes.com ("Website"). Once on the Website, an eligible entrant may follow the links and instructions to complete and submit the information on the registration form including, but not limited to, his/her first and complete last name (no initials), date of birth, valid e-mail address, phone number, street address (no P.O. Boxes will be allowed), city, state, and zip code. After submitting the registration form, the entrant must follow the links and instructions to complete a profiler questionnaire ("Questionnaire") consisting of five (5) questions. Upon completing the Questionnaire, entrant will receive one (1) entry into the Promotion.

Bonus Entries: After following the instructions on the Website to register and enter the Promotion, an entrant may obtain additional Promotion entries. Upon entering the Promotion, entrant will be presented with options to share the Promotion by clicking the buttons to share the Promotion via Facebook®, X™, or via a personalized URL. There is a limit of five (5) bonus Promotion entries per available method (five [5] via Facebook Share, five [5] via X Share, and five [5] via Personalized URL), during the Promotion Period.

Entry Limit: There is a limit of one (1) entry and fifteen (15) bonus entries, for a total of sixteen (16) total entries per person during the Promotion Period. If more than one (1) entry and fifteen (15) bonus entries are received from the same person, telephone number and/or e-mail address the excess entries will be disqualified. RANDOM DRAWING:** On or around March 1, 2024, the Administrator will randomly select one (1) potential grand prize winner, one (1) potential first prize winner, one (1) potential second prize winner, and one (1) potential third prize winner from all eligible entries received during the Promotion Period. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules, as determined by Sponsor and Administrator, in their sole and absolute discretion.
- 5. PRIZES, APPROXIMATE RETAIL VALUE ("ARV"), AND ODDS OF WINNING:**

- C. Second Prize (1):** The second prize is a five hundred dollar (\$500) 1800flowers electronic gift card (“Second Prize”). There will be no more than one (1) Second Prize available in the Promotion. The ARV of the Second Prize is \$500.
- D. Third Prize (1):** The third prize is the prize winner’s choice of a five hundred dollar (\$500) physical or electronic gift card to redeem on any product in-store or online from either Kay Jewelers, Zales, or Jared The Galleria of Jewelry (“Third Prize” and together with the Grand Prize, First Prize, and Second Prize, the “Prizes” or each a “Prize”). There will be no more than one (1) Third Prize available in the Promotion. The ARV of the Third Prize is \$500.
- E. Total ARV:** The total ARV of all prizes in the Promotion is \$6,500 USD.
- F. Odds of Winning:** The odds of winning a prize depend on the number of eligible Promotion entries received during the Promotion Period.
- G. General Prize Conditions:** There is a limit of one (1) Prize per person/household. The use of a gift card is subject to the terms and conditions set forth thereon which shall govern the use of the gift card. After each random drawing, Administrator will notify the potential winners via e-mail at the e-mail address provided at the time of registration. Before being declared the official winner of a Prize, the potential winner will be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release (except where prohibited), tax acknowledgement (as applicable), and any other requested documents within five (5) calendar days from the date of attempted notification or the applicable Prize may be forfeited in its entirety and awarded to an alternate winner, at the Sponsor’s sole and absolute discretion. Sponsor reserves the right to conduct

a background check on any potential winner and reserves the right in its sole discretion to disqualify any person based on such background check if Sponsor determines in its sole discretion that awarding the Prize to such potential winner might reflect negatively on Sponsor or Administrator. Failure by potential Prize winners to agree to a background check may result in disqualification. When you enter at the Website, you may be asked to consent to receive promotional emails and reminders for upcoming promotions and information about Sponsor. Consenting to receive such emails is optional and does not have to be agreed to in order to be eligible to enter the Promotion and does not improve your chances of winning.
